It tells your reader where you found any information or ideas that are not your own. It is a shortened citation in parentheses and includes the author's last name, publication year, and the page number (if quoting).

Many citations used as examples in this guide are fictitious and created for illustration purposes. General Rules: Intext Citations-APA Style Guide 6th (p. 170) requires you to cite your sources in the text of your paper using author-date. Include author, year, page(s). Provide the ...
