De Facto Parent Recognition No updates required since June 2, 2021 De facto parenting laws apply when someone is raising a child but is not a legal parent of that child. De facto parenting laws provide these parents with some limited legal rights to the child, for example, possibly granting visitation, custody or even full parenting rights should the parent's relationship
